

Open letter to Hon Amy Adams, Minister of Justice and Courts, His Honour Judge Laurence Ryan, and Ms Kathryn Beck, President of the New Zealand Law Society.

11 April 2017

Dear Minister, Judge, and Ms Beck,

Re: New Zealand Family Court

The Backbone Collective is an independent body taking action to change NZ's alarming violence against-women statistics (domestic and sexual violence and abuse being the most prevalent forms in NZ) by examining the present response system through the eyes of its users - women who have experienced violence and abuse.

We launched Backbone one month ago and since then our membership has been steadily growing and we have been inundated with emails and facebook messages from women wanting to share their experiences of the system that is supposed to keep them safe and help them rebuild their lives. We currently have 556 members – all are women who have experienced violence and abuse. An additional 81 people have registered with Backbone as supporters. These numbers are steadily increasing every day.

The NZ Family Court is a key part of the overall response system. During our establishment phase we surveyed 156 women who had experienced violence and abuse to ascertain how they wanted Backbone to be designed and asked them what their priority issues were for Backbone to collect their voices about. The Family Court was the priority issue for these 156 women.

After we launched on 5 March 2017 we asked ten of our members whom we understood had been involved in Family Court proceedings to each submit questions that they would like to ask those in authority about the Family Court. Those women have given 160 questions about how the Family Court functions presently. These have been collated into Backbone's first Watchdog report (copy attached). We have included the questions as the women submitted them to us — they are their questions and we have not edited them in any way. The report was released publicly last Friday, 7 April 2017 and since that time many women have contacted us to join the Backbone. We believe the

three of you have the authority and responsibility to answer these questions for the 10 women who asked them, but also for all the members of Backbone. To assist you we have prepared the attached tables listing all 160 questions and identifying which questions we think apply to whom. You will see we have a column showing which of you Backbone thinks is responsible for each question. If we have incorrectly identified you as the person with the authority and responsibility for any individual question please note that in the blank column headed 'correct entity responsible for answering'. This might be one of the other two people this letter is addressed to or someone else.

We appreciate it might be easy for you to think that these questions are a 'one-off' pertaining only to one woman's case and that to answer them would require a review of the relevant Family Court file. However, since we released the Watchdog report four days ago we have been inundated with women emailing, phoning and sending messages via Facebook saying that they could have asked all those questions with respect to their own case – that reading the questions was akin to reading about their own experience in the Family Court. This leads us to conclude that these are not isolated examples of failures in the Family Court, but rather the tip of an iceberg, with many more stories just under the surface.

Please send us your responses to the questions that you have authority and responsibility for to ruth@backbone.org.nz by Friday 28 April. We will be publishing your responses on our website and will be keeping a table to show length of time taken to respond. The Backbone Collective is committed to ensuring that the system that responds to women when they experience violence and abuse is safe, accountable and transparent.

We look forward to your replies.
